JANUARY MEETING MINUTES - Approved unanimously

AUCTION

The Board unanimously approved the following auction plans: The spring auction will be replaced by a fund drive capped by a Zoom "telethon" on March 27. Subsequent annual auctions will be moved forward from spring to the previous fall. The live auction for the 2021-2022 fiscal year is tentatively scheduled for October 23, 2021. The financial target for these two events has not been defined.

MINISTERS REPORT (see the original report for complete details)

Michael Morrell was hired as <u>AV Tech</u> and started in early February.

Rev. David is working with Sophia to meet with Waukesha Country Sheriff Severson on <u>concerning hiring and</u> <u>immigration practices</u>.

Discussions are ongoing with Lake Country UU on <u>possible joint Religious Education arrangements</u> after the pandemic. The Board unanimously approved continuing those discussions.

Now that vaccinations are well underway, Rev. David plans to restart the <u>Pandemic Safety working group</u> to plan for the rest of 2021.

TREASURER'S REPORT (see the P&L detailed report and summary)

Lisa presented a <u>new financial dashboard</u>, which was received with a round of applause. It shows the current balances on major line items, plus the balance for those accounts for each of the previous 3 years.

Recent payments from the <u>Alice Rider Trust</u> were about \$3000 above expectation. Lisa is investigating.

Potential future financial actions include:

- Expand the categories in the dashboard.
- Update the budget to include all accounts (e.g., Emergency Fund).
- Develop a calendar of events that affects the budget.
- Rebuild the QuickBooks file.
