MINISTERS REPORT (see the original report for complete details)

Rev. David has invited a group of people to a "Re-imagining Worship" workshop to discuss how we can do worship even better now in the pandemic and beyond.

Sunday's Water Communion at Horeb Springs Park was attended by 35-36 adults and at least 4 children.

<u>Barb Johnson's Memorial</u> service on September 15 will be live-streamed as well as in-person at the church. The church has been cleaned and COVID mitigation actions have been taken.

The Lake Country UUC search for a <u>new Director of Religious Education</u> continues. Discussions with UU Church West in Brookfield about potentially sharing programming are ongoing.

TREASURER'S REPORT (see the financial dashboard and P&L report)

Church finances remain solid. No significant news to report.

ADDITIONAL TOPICS

Patty Vanderpoel has graciously stayed with us as we search for an <u>administrator replacement</u>, but it is well past time when we all expected this would be concluded. The Board unanimously approved releasing Patty from her administrator responsibilities at the end of September. Short-term, Lisa will cover Patty's bookkeeping related activities, and Rev. David will cover Patty's other responsibilities. The search for a church administrator and professional bookkeeper continues. Rev. David and Lisa will work together to update the administrator job description to remove responsibilities that will be covered by the professional bookkeeper.

The <u>Board Vice President</u> position is currently open. The sole responsibility of the Vice President is to cover for the President when the President is unavailable, although the position is not called out in the UUUC Bylaws. The Board unanimously agreed to leave the Vice President position open until further notice. A Board member will be temporarily appointed to cover for the President whenever the President is unavailable.

Status updates on the stairs carpet replacement and sanctuary pendant lights LED conversion <u>Building & Grounds projects</u> were given. See the Board Action Item list.

The <u>Fall Auction</u> has been cancelled because an indoors event is too risky given the current pandemic conditions. The next auction will probably occur in spring.

The Board unanimously approved establishing a <u>UU of the Year "perpetual" plaque</u> with one plate for each recipient, engraved with their name and year.
